### 20.31 Apologies

### 20.34 Matters arising:

*War memorial:* Councillor Eastabrook had a quote and the proposed wording for the stone around the council, but hadn't yet contacted the village hall committee. He had been separately quoted c. £700 for the stone and engraving, and £540 for fitting the stone. He agreed to write to the VH committee asking permission to mount the stone on the buttress. He wondered if a plinth below the stone would be a good idea, to place wreaths, etc., on, but it was decided that this could be considered after the stone was installed. As there could not be an unveiling ceremony at the moment it was decided to defer this until later.
